GENERAL TERMS & CONDITIONS:

The Le Club AccorHotels General Conditions of Use and Le Club AccorHotels Meeting Planner General Terms and apply to this Offer and the terms and conditions herein.

"Eligible Event" means any meeting, conference or other professional event booked and held at the hotels participating in this Offer, and in accordance with the Le Club AccorHotels Meeting Planner General Terms & Conditions.

"Offer" means the award of Le Club AccorHotels bonus Rewards points.

OFFER TERMS AND CONDITIONS:

- 1. To qualify to receive the Offer, the following criteria must be met:

Section 5: Prizes

7. Prize Components & Conditions:
